Transamerica Premier Life Insurance Company ("Petitioner") is an Iowa 14 domiciled insurance company that received its certificate of authority to transact life and 15 disability insurance in Arizona effective December 12, 1975. 16 2. Effective October 1, 2020, Petitioner, the non-surviving entity, merged into 17 Transamerica Life Insurance Company (TLIC), NAIC No. 86231, an Iowa domiciled insurer 18 and the surviving entity. TLIC is authorized to transact insurance in Arizona. Petitioner 19 voluntarily surrendered its certificate of authority to the Department. 20 3. The Insurance Commissioner of Iowa approved the merger of Petitioner into 21 TLIC on September 9, 2020. 22
