12	insurer, received its certificate of authority to transact property and casualty insurance in	
13	Arizona effective June 1, 2000.	
14	2. In order to transact insurance business in Arizona, Petitioner placed a deposit with	
15	the Arizona State Treasurer to protect Arizona policyholders (the "Deposit").	
16	3. Petitioner currently has a \$550,000 Deposit with the Arizona State Treasurer.	
17	4. Petitioner has filed an application dated March 25, 2021 for release of its deposit	
18	pursuant to A.R.S. § 20-588(A)(2).	
19	5. Petitioner has provided certification from the State of Maryland Department of	
20	Insurance that as of December 31, 2020, it holds \$2,500,000 par value in securities in trust fo	r
21	the benefit of all policyholders and creditors of Petitioner.	
22	6. The Maryland Department of Insurance certificate satisfies the trust deposit	
23	requirement prescribed in A.R.S. § 20-213.

1	CONCLUSIONS OF LAW
2	1. The Director has no personal liability for the release of such deposit so made by him
3	in good faith as provided in A.R.S. § 20-588(B).
4	2. Petitioner is entitled to the release of its Deposit pursuant to A.R.S. § 20-213 and
5	20-588(A)(2).
6	ORDER
7	THEREFORE IT IS ORDERED that the \$550,000 trust deposit shall be released to
8	Petitioner.
