FINDINGS OF FACT

- 1. 21st Century Insurance Company of the Southwest ("Petitioner") is a Texas domiciled insurance company that received its certificate of authority to transact property and casualty insurance in Arizona effective June 26, 1996.
- Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of authority to the Director.
- Petitioner has no outstanding obligations under any policy of insurance, whether written direct or through reinsurance ceded to it, to policyholders or claimants who are residents of this State.
- 4. Petitioner is not the subject of any pending investigation or market conduct examination and does not owe this Department any filings or fees.
- 5. Petitioner has a \$100.00 deposit with the Insurance Examiners' Revolving Fund ("IERF").
