Based upon reliable evidence provided to the Director of Insurance and Financial Institutions by the Deputy Assistant Director of the Financial Affairs Division of the Arizona Department of Insurance and Financial Institutions ("Department"), the Director finds as follows:

**FINDINGS OF FACT**

1. West Virginia Mutual Insurance Company ("Petitioner") is a West Virginia domiciled insurance company that received its certificate of reinsurance accreditation to transact reinsurance in Arizona effective April 18, 2016.
2. Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of reinsurance accreditation to the Director.
3. Petitioner has no outstanding obligations under any policy of insurance to policyholders or claimants who are residents of this State and does not currently assume risk from any Arizona domestic insurer, and is not a party to any reinsurance agreement with an Arizona domestic insurer.
4. Petitioner is not the subject of any pending investigation or market conduct examination and does not owe this Department any filings or fees.

**CONCLUSIONS OF LAW**

Petitioner has complied with the provisions of A.R.S. § 20-217 relating to the surrender of its Certificate of Reinsurance Accreditation and its withdrawal from the insurance business.

**ORDER**

The surrender of the Petitioner’s certificate of reinsurance accreditation is accepted.
